

## Postcards from the Future Competition 2021 - Terms and Conditions of Entry

---

1. The Promoter ("Promoter") of the Postcards from the Future Competition 2021 (the "Competition") is Sutherland Shire Council ABN 52 018 204 808.
2. Information on prizes and how to enter form part of these terms and conditions of entry ("Terms and Conditions").
3. Each entry must be entered in accordance with these Terms and Conditions. By entering the Competition, each entrant agrees to be bound by these Terms and Conditions. The Promoter may in its discretion refuse to award any prize to any entrant who fails to comply with these Terms and Conditions.
4. Entry to the competition is free and open to individuals who live in Sutherland Shire and/or study at a primary or high school in Sutherland Shire.
5. Employees and immediate families of the Promoter, associated companies and agencies, are eligible to submit entries. However they are ineligible to be entered into the Competition.
6. The Competition opens at 9.00am EDST Monday 25 October and closes at 11.59pm EDST Monday 15 November 2021 ("Competition Period"). Any entry received after the expiry of the Competition Period will be deemed invalid. No responsibility is accepted for late, lost, delayed or misdirected entries.
7. Entry forms and submissions ("Entries" or "Entry") to the Competition can be in the form of text or visual art. Entries are to be submitted on the Postcards from the Future entry form to Sutherland Shire Council online, by email, post or drop off, as specified below:

  - post the completed entry form in an envelope to the Future Postcards, Sutherland Shire Council, Locked Bag 17, Sutherland 1499
8. The prizes are:
  - Primary school student stage 1, stage 2 and stage 3 category winners will each receive a \$100 gift voucher and runner up receive a \$50 voucher.
  - High school student stage 4, stage 5 and stage 6 category winners will each receive a \$100 gift voucher and runner up receive a \$50 voucher.
9. All electronically submitted entries must be limited to 2MB.
10. Entries may be anonymous. However they are ineligible to be awarded a prize in the Competition.
11. Entries must not contain any material that is defamatory, discriminating, obscene, indecent, harassing, or threatening or is otherwise unlawful. Any entry that at the discretion of the Promoter, is deemed to be offensive, discriminatory, defamatory, obscene, indecent, harassing, or threatening, will immediately be disqualified from entering the Competition. The Promoter's decision in relation to any aspect of the Competition is final. No correspondence and/or discussion will be entered into.
12. Entrants submitting a drawing to the Primary School Student category of the Competition must, at the time of entry, be a student at primary school. Entrants submitting written work to the High School Student category of the Competition must, at the time of entry, be a student at high school.
13. Entries will be assessed by a panel of judges selected by the Promoter. The winners will be determined by a panel of judges who will consider a number of criteria including: relevance, originality, writing style and/or overall effect.

The decisions of the judging panel are final and no correspondence and/or communication of any kind in relation to the panels' decisions will be entered into. The judging panel is under no obligation to award a prize in any category.

14. Entries must reflect the entrant's ideas of what they want Sutherland Shire to be like in 2032.
15. The Entrant warrants that:
  - the Entry is their own creation,
  - the Entry is attributable only to the Entrant, and
  - the Entry and the acts of the Promoter in relation to the Entry do not infringe upon the copyright, intellectual property rights, or moral rights of any person.
16. Entrants agree that by entering the Competition they authorise and grant the Promoter a non-exclusive and non-transferable licence to exercise intellectual property rights in the Entry.
17. In entering the competition, the participant gives The Promoter authority to reproduce, publish, communicate or display the work online (including social media), in presentations, videos, publications and, if selected, for public display at various venues. Entries may be exhibited or reproduced in any medium. The Promoter is not required to pay a fee to exercise any intellectual property rights.
18. Entrants agree that the Promoter may modify the Entrant's Entry as it sees fit to meet its requirements without further correspondence with or reference to the Entrant.
19. The Promoter is not responsible for any costs arising from entry into the competition, including but not limited to: costs to access internet or phone providers, equipment costs and so on. Responsibility cannot be accepted for lost, delayed or damaged entries.
20. Entries will not be returned.
21. By entering the Competition each entrant agrees to indemnify the Promoter against all claims, loss, damage, costs (including legal costs), or liability whatsoever arising out of or in connection with the Entrant's breach of these Terms and Conditions.
22. The Entrant shall indemnify and release the Promoter in respect of any judgement, action, or liability for all claims, loss, damage, or injury to persons or property arising from the negligence of the Entrant; or against any breach by the Entrant of any third party intellectual property rights and against any act or omission by the Entrant commenced by a third party against the Promoter.
23. Winners will be notified by email or phone.
24. Winners will be announced and the prizes presented electronically during the week of Monday 30 November 2021.
25. Winners are solely responsible for complying with any rules and expiry dates in relation to the prizes.
26. Winners will have three months to claim their prize. Failure to claim the prize within this time frame will result in forfeiture of any prize.
27. Council shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, as a result of receiving the prize, except for any liability which cannot be excluded by law.
28. If for any reason this Promotion is not capable of running as planned including, but not limited to COVID-19, technical failures, unauthorised intervention, fraud or any other causes beyond the control of Council which corrupts or affect the administration, security, fairness, integrity or proper conduct of this Promotion, Council reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Promotion.
29. The Promoter collects entrants' personal information in order to notify them if they have won and to use for Competition reporting only. Entrants further consent to the disclosure by the Promoter of their personal information to the related entities of the Promoter and to any third-party services provider assisting the Promoter in the conduct of this Competition. In accordance with the relevant privacy legislation, a request to access, update or correct any information should be directed to the Promoter.
